Re: The Detrimental Impact of Europe's Immigration Policies on Sudanese and other East Africans

Dear Senator Wicker and Congressman Smith,

We, the undersigned 134 Sudanese, scholars, human rights organizations and leading activists, write to request your urgent assistance in raising serious concerns with your colleagues in the Organization for Security and Cooperation in Europe about the alarming impact on East Africans of efforts by E.U. countries to curb immigration. In addition to creating grave risks to personal health and safety for individuals fleeing from Sudan and other countries in Africa, these policies set a dangerous precedent that undermines international peace and security by ignoring basic human rights and international law; and tolerating genocide, crimes against humanity and war crimes rather than holding accountable those responsible for mass atrocities.

Fundamental to addressing the immigration crisis in Europe is the imperative to address the root cause of immigration -- intolerable living conditions created by violent dictatorships in Sudan and other African countries. Desperate conditions have created a market for smugglers, which has resulted in countless deaths due to dangerous crossings of the desert and the Mediterranean Sea, widespread human trafficking including documented slave markets in Libya, and torturing immigrants in order to extort funds from family members who are forced to watch videos of loved ones enduring intolerable suffering.

In the case of Sudan, the European Union is funding the regime hoping to curb immigration; however in reality, it is funding the very source of violence and corruption that creates displacement and facilitates smuggling. Particularly shocking is the decision of French and Belgium officials to allow the notorious Sudanese intelligence service into their countries to identify Sudanese as part of a deportation process that has resulted in arrests, beatings and torture upon return to Sudan. These dangerous decisions of expediency that include forced return of refugees who will face persecution on account of their race, religion, and/or political opinion are blatant violations of international law that must be confronted if the U.S. and its allies are to enjoy peace and security. These goals can only be achieved by championing freedom, promoting and protecting basic human rights, and finally and foremost, securing justice for all.
